Payments made directly by a mortgage company: If your mortgage company pays your taxes directly for you, please ensure they have the correct mailing address and parcel identifying information from your tax bill to include with the payment.

Payments by mail: Postmark is accepted as the date of payment. If you need a receipt for your payment, be sure to enclose a self-addressed stamped envelope with your payment. If you are sending an escrow check, please be sure to endorse it before sending. Please make checks payable to: **Town of Watertown**
